- #14 Training: USEA T Test A + 3'3" Jumps
- #15 Preliminary: USEA P Test A + 3'7" Jumps

**Please include current negative coggins, CBF release form and full payment with entry.**

### **Rules for the Day:**

- All horses must have proof of 12-month negative coggins (may be on file)
- All riders must wear a certified helmet with attached chinstrap at all times when mounted on the property
- All classes run generally under USEF/USDF/USEA rules for dressage and eventing
- Any dressage test may be read.
- "Clinic Attire" acceptable (neat and tidy)
- All tests may be entered more than once
- Extra jumping rounds may be added at the gate, but must be pre-entered once
- Management reserves the right to combine or split any classes due to number of entries
- Management reserves the right to refuse any entry for any reason
- Competition will take place rain or shine. No rain date, no refunds.
- Entries mailed after April 10<sup>th</sup> must include the late fee.
